4. Bark & Board Inn, LLC will treat every pet with dignity and respect and is not liable for death resulting from pre-existing medical conditions, age-related illness, or unforeseen medical emergencies

Owner releases Bark & Board Inn, LLC, its owners, employees, contractors, and agents from liability for injuries, illness, loss, or death except where caused by gross negligence or willful misconduct as permitted by applicable law.
